AMEND SCHEDULE OF AUTHORIZED PUBLIC DEPOSITORIES

Background

The School Board must annually approve the institutions to which District funds are deposited. Attachment A is the list of authorized public depositories for 2007. Administration requests Board approval for these depositories.

In March 2007, the Kenosha Unified School District distributed a Request for Proposal for Placement Agent Services. After a review of the responses, Robert W. Baird & Co. has been awarded the business.

Administration has updated the list to remove Stifel, Nicolaus and to add Baird. Stifel, Nicolaus has served as the District's placement agent for borrowings between April 2004 to the present. All other financial institutions remain the same.
