CNA Checklist

Do you meet the academic requirements?

- Students must be 16 years of age by the start of the class
- Students must have a 2.6 cumulative, unweighted GPA at the end of their sophomore year
- If student does not meet the GPA requirement they can do one of the following:
 - ACT reading score of 15+ **or** an Accuplacer reading score of 237. Students must have ACT scores or have taken the Accuplacer test prior to submitting their application.
 - You can sign up for the Accuplacer test assessment by either calling Gateway at [1-800-247-7122](tel:1-800-247-7122) or contact your [New Student Specialist](#) to schedule. Applicants must complete assessment testing Accuplacer to include Reading, Math, Writing & English.
- Did you take a prerequisite class?
 - Medical Terminology, Exploring Health Occupations, any MedSci Course (Indian Trail) or any PLTW Biomedical (LakeView).

Students not meeting prerequisite course can still apply and will be admitted if space is available

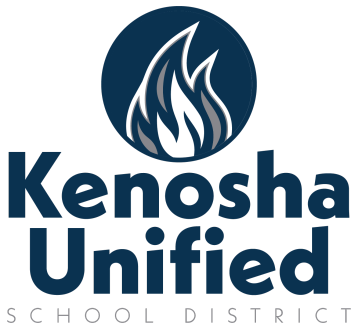

Dear Parents/Guardians,

Your student has expressed an interest in taking the Nursing Assistant (NA) class. The NA class is available to all juniors and seniors that meet academic admissions requirements.

Parents and students please be aware that enrollment and acceptance into this program means the student is now a part-time college student. Students who have any issues, concerns, etc. with their new university/college, must contact that particular institution for a possible resolution. Kenosha Unified School District counselors will remain in contact with your student to ensure that the experience is being maximized.

If a student receives a failing grade(s) or drops a course for which the school district has made payment, the district will request reimbursement for all costs related to the course(s). Reimbursement will be requested from the student if he/she is an adult or from the student's parents/guardians, if the student is under 18 years of age.

Benefits of CNA program:

- Prepares students to perform basic supportive skills in caring for patients in various healthcare settings.
- Graduates become CNA's upon passing the state test and are placed on the Wisconsin Nurse Aide Registry (test cost is \$125).
- Once student has obtained their certification they can sign up for Youth Apprenticeship
- Fulfills a prerequisite for Gateway Technical College (GTC) nursing programs.

IMPORTANT NOTES:

1. Students who fail to provide reimbursement for a failed or dropped course(s) as described above are not eligible for any SCNP, ECCP, Contract for Service, or GTC Academy course(s) until payment is made.
2. All textbooks and/or equipment provided for the course(s) must be returned to the district Career and Technical Education office (3600 52nd St.) within two weeks of completion of the college course(s) or reimburse the district for the cost of the textbooks and/or equipment.
3. **Transportation is not provided by Kenosha Unified to the class site or clinical site.**
4. Attendance at all classes and clinicals is extremely important, missing too many hours of class may result in a failure. Contact GTC for all attendance related questions.
5. Students who fail the NA course will receive a failing mark on their college transcript with Gateway Technical College. Additionally, those who drop after the drop window will receive a withdrawal mark on their college transcript with GTC. These may affect future college acceptance and financial aid at Gateway.

**Contract For Service Participation Approval Form
Gateway Technical College Nursing Assistant**



Gateway's Nursing Assistant Course requires program acceptance to the Nursing Assistant program, requiring an application (app fee available), placement testing (\$15), and background check & medical document manager (\$85) prior to the first day of class. Each clinical placement has site specific requirements which may include COVID-19 vaccination requirements. These requirements are subject to change with little or no notice. Students must also complete an online registration form to enroll in the Contract For Service Nursing Assistant section. After successfully completing the course, students have the opportunity to take the State of Wisconsin's licensure exam to become a Certified Nursing Assistant (CNA). Please note, there is a \$125 fee for exam. An average of 78% or better is required on all coursework in order to pass the classroom part of the course. Attendance is very important in this class. There are federal requirements of attendance. Too many hours missed could result in an incomplete or a failure of the course.

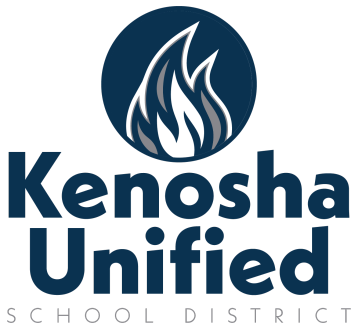

Terms and conditions:

1. The driver shall use a privately owned motor vehicle for the specific purpose of transporting themselves to and from the locations noted above as authorized by the district.
2. The driver shall not be compensated for the use of his/her motor vehicle.
3. The driver agrees that he/she will be the sole driver of his/her motor vehicle and will not permit other students use of this transportation during or for the above specified purpose.
4. The driver shall possess a valid Wisconsin operator’s license and provide the district with proof of such license. In certain circumstances, the district may accept a valid operator’s license issued by another jurisdiction.
5. The driver understands this agreement must be entered into each semester or as changes occur.

Additional GTC Information

Requirements for participation in the program:

- Medical Document Manager clearance prior to clinical including but not limited to:
 - TB
 - *Hepatitis B
 - **Tetanus: Full Tdap vaccine every 10 years OR Immunization Declination Waiver Form completed by your healthcare provider indicating medical reason OR clergy for religious reasons; you cannot self-waive this requirement.
 - **Influenza: Only for clinicals scheduled between September 1 and April 30 of each year.
 - COVID-19: Each individual clinical site has their own COVID-19 policy that individuals must comply with. Some of our clinical sites will accept medical or religious waivers; however, we cannot guarantee that a waiver request will be accepted. For specific clinical site medical documentation, please view the [Nursing Assistant COVID, Influenza, and Site Requirement Information](#) document.
 - **May be self-waived*
 - ***May be waived only by healthcare providers or clergy*
- Access to technology including:
 - Reliable, frequent access to a computer with internet access. While much of the work could be completed on a smartphone, some readings and features of Blackboard work best on a computer. Exams and quizzes must be done on a computer/laptop that has webcam access. All quizzes and exams must be taken through the Respondus Lockdown Browser application in order to be proctored.
 - Access to MyGateway to utilize Gateway Email (gmail) and Blackboard
- Good attendance. The State of Wisconsin Regulatory Agency requires mandatory attendance of 75 hours for this course. There is an allowance of up to 8 hours absence/tardiness with mandatory documented homework assignments. If there is a college-related cancellation of course time, mandatory make-up day(s) will be assigned to the course to ensure compliance with state regulations.
- Students must earn a 78.0% (2.0) for the classroom portion to proceed to the clinical experience. Those who pass both classroom and clinical are eligible to take the state certification exam.

Textbooks, Uniform, Supplies & Materials:

- All Nursing Assistant students must wear solid navy blue uniform tops and bottoms. Students are responsible for purchasing these. Uniforms may be purchased at Follett Bookstores on Gateway campuses. White socks and white shoes are also required. These may be slip-on or tied, but no clogs, Crocs™ or sandals are acceptable.
- The professional dress code is strictly enforced beginning the first day of class. Long or artificial fingernails, nail polish, colognes, and heavy make-up are prohibited. Long hair must be tied back. Jewelry should be minimal. Piercings other than ears may not be visible.
- Students must also bring a watch with a second hand, notebook, a black pen, and any other supplies needed to be successful in the class.

Certification Test and Fee

After successful completion of the course, students will be prepared to take the State CNA certification test. Currently, this test is \$125. The certification test is not a requirement of the course but may be required by employers and/or admission to 2 or 4-year college nursing programs. Students must complete the certification exam within one year of completing the course. If more than one year lapses between completing the course and taking the exam, the student will have to take the course again. Review the [Wisconsin Nurse Aide Candidate Handbook](#) for information regarding signing up for your class. Your Gateway instructor also will provide information to you before the end of your class.
